However, Priumvada passes away too soon from a snake bite and leaves behind her last lines, which perfectly capture her agony and longing:

I don't know the names of most of the flowers around me, and few trees even know my name. I also haven't seen the stars nearly enough to cause my death. I detect a terrible hand. A chilly, hazy mist pulls me away from the warmth of your touching limbs as the whole dark night descends on me. I'm no longer yours, yet I'm going somewhere and seeing drab landscapes, dark nations, and that awful stream. They separate me from thee far, and I wonder whether we'll ever find each other. I have no idea where death lies in its vast, terrifying domain. (Collected Poems, Love and Death, p. 117)
